- How can urban planning help to foster a just, healthy and green transition?




Fig. 40. Prevalence of difficulty accessing recreational or green areas by income quartile (2016)

Act on the environments in which people live.


Invest in urban infrastructures that may it easy for people to engage in active travel.

Co-designing solutions: involving communities across the social gradient

WHY?

Involving communities in policies/practices that affect them helps to ensure they address real needs, is empowering and gives them a vested interest in their success.

HOW?

Make it mandatory for local authorities and developers to engage residents in designing, implementing, maintaining and evaluating housing development or green space initiatives.

Build a relationship of cooperation and trust

Ensure participation is meaningful and not tokenistic

Recognise the commitment of and support people involved

Ensure that participatory processes are inclusive and representative
