The Austrian National Public Health Institute (Gesundheit Österreich GmbH, GÖG) is the institution responsible for researching and planning public healthcare in Austria, and also acts as the national competence and funding centre for the promotion of health. It is organised in three business units. Set up by federal law on 1 August 2006, GÖG has the federal government as its sole shareholder, represented by the Ministry of Health.

The Austrian National Institute for Health Services Research was founded in 1973. We analyse data, provide comprehensive information in the field of public health policy, and facilitate reform and innovation processes.

The Austrian National Institute for Quality in Health Care was founded in 2007 (Act on Healthcare Quality). We develop standards, maintain registries, evaluate the quality of healthcare interventions and provide information and decision support to promote high quality healthcare in Austria.

The Austrian Health Promotion Fund was founded in 1998 (Health Promotion Act). We promote health and support initiatives to establish and improve knowledge, competences, and networks by granting financial assistance and offering guidance.




